Dear Mr. Holden:

With this notice, Conemaugh Generating Station is informing the Department of its intent to achieve permanent cessation of coal combustion by December 31, 2028 (§423.19(f)) for the Station's two existing coal-fired steam turbine-driven electric generating units (EGUs). Under §423.11 – Specialized Definitions,

(w) The term "permanent cessation of coal combustion" means the owner or operator certifies under §423.19(f) that an electric generating unit will cease combustion of coal no later than December 31, 2028

The contents of this notice, pursuant to §§423.19(b) and (f)(2) requirements, are presented below.

EGUs permanently ceasing coal combustion (PC3)	Unit No. 1 and Unit No. 2
Expected date that PC3 status will be obtained	12-31-2028 for both units
Retirement or fuel conversion	Retirement for both units
Retirement approved by applicable regulatory body (PJM Interconnection)	Not as of the date of this notice - a request for generator deactivation (retirement) is expected to be submitted by Conemaugh Station to PJM in 2028 or sooner in accordance with PJM's requirements ¹ . Conemaugh Station will forward the request and expected approval from PJM to the Department when available.
Timeline and interim milestones to achieve PC3 status	Not yet developed, dependent on the approved deactivation date
